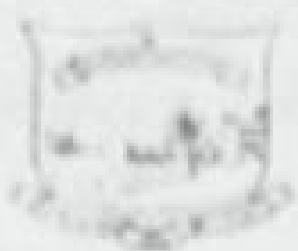



2. The tenders / bid shall be opened at the chamber of health officer Kozhikode Municipal Corporation, Calicut on the prescribed date and time **LATE TENDERS WILL NOT BE ACCEPTED.**
3. Tenders / bid must be quoted in Malayalam / English language only.
4. The rate quoted should be valid for a period of 90 days. The rate quoted must be both in figures and words and it must be firm for the supply period.
5. **Supply should be made within 10 days on receipt of the supply order.**
6. Tenders fee is Rs:2500/- + GST shall be payable online.
7. Each tenderer shall furnished 1% of the total cost of the material as Earnest Money Deposit (EMI) will be accepted only through online payment mode. No bidder (except SSI units within the state registered with the stores purchase department) shall be exempted from remittance of EMI/Bid security vide (GO(P) No448/05 fin. Dated 13.10.2005
8. All rules and regulations of the Tender /bid shall be in accordance with the Store Purchase Manual of the Govt. of the Kerala
