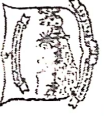

1. All Tenders / bid shall be submitted only through manual submission

2. The tenders / bid shall be opened at the chamber of health officer Kozhikode Municipal Corporation, Calicut on the prescribed date and time LATE TENDERS WILL NOT BE ACCEPTED.
3. Tenders / bid must be quoted in Malayalam / English language only.
4. The rate quoted should be valid for a period of 90 days. The rate quoted must be both in figures and words and it must be firm for the supply period.
5. The rate quoted should be included of GST.
6. **Supply should be made within 10 days on receipt of the supply order.**
7. Tenders fee is Rs:2500/- + GST
8. Each tenderer shall furnished 1% of the total cost of the material as Earnest Money Deposit EMI). No bidder (except SSI units within the sate registered with the stores purchase department) shall be exempted from remittance of EMI/Bid security vide (GO(P) No448/05 fin. Dated 13.10.2005
9. All rules and regulations of the Tender /bid shall be in accordance with the Store Purchase Manual of the Govt. of the Kerala
10. As the procurement procedure is to be completed in a limited time, vendors are requested to quote the rate of the ready stock. Time for back to back procurement etc will not be provided.
11. All central and state taxes Should be applicable as per the law.
12. Then successful tender will have to execute an agreement deed in the prescribed form for the due fulfillment of the contract after depositing 5% of the contract value as security deposit.
13. The bidder / Tenderer should have valid CGST / SGST registration. Copy of Each CGST / SGST registration certificate should be enclosed along with tender
14. The bidder/Tenderer should have valid PAN/TIN copy of PAN/TIN allocation letter should be enclosed along with tender
15. The Secretary, Kozhikode Municipal Corporation reserved the right to accept or reject any or all tender without assigning any reason thereof
16. All disputes are subject to jurisdiction of courts only at Kozhikode.
