Terms and Conditions are as follows:-

1. The proposal is for construction of bus waiting shelters and handover to Municipal Corporation. The ownership of bus waiting shelters shall vest with Kozhikode Municipal Corporation.
2. The expenses for construction, maintenance and repair, electricity charges and other recurring expenses relating to the bus shelters will have to be borne by the bidders.

3. Standard equipments and materials should use for the work and the quality of the materials shall be ensured by the bidder. Bus shelters must be unity in colour as per the instruction of Municipal Corporation.
4. The interested bidders will be permitted to display advertisement on the bus waiting shelters in a restricted manner by providing boards/hoardings. The display shall be made in abeyance to the prevailing rules and regulations of Public Works Department, K.S.E.B, National Highway and Police authorities and necessary approvals shall be made available as their own.
5. Necessary lighting arrangements shall be provided with electricity /solar power.
6. The name "Kozhikode Municipal Corporation" should be displayed in each bus waiting shelter.
7. Necessary seating arrangements with standard materials should be provided.
8. The bidders shall have to furnish their complete offers and conditions in this regard, if any, with term of contract offered, mode of executing maintenance, financial and technical back ground and experience, infrastructural facilities and ability proving credentials etc.
9. Any additional benefits or service offered shall be mentioned in the bid specifically and weightage shall be given accordingly.
10. The Municipal Corporation Council has the right to demolish/shift the bus waiting shelters for any development works if necessary.

All other terms and conditions are as per the prevailing State Government Rules. The right to accept and reject any offer, without furnishing any reason, shall vested with Municipal Corporation Council. More details can be had from the Municipal Corporation Office during the office hours.
